# **PRIVACY POLICY**

This Privacy Policy applies between you, the User of this Website and **Apirox**, **s.r.o.** the owner and provider of this Website. **Apirox**, **s.r.o.** takes the privacy of your information very seriously. This privacy policy applies to our use of any and all Data collected by us or provided by you in relation to your use of the Website.

Please read this privacy policy carefully.

# **Definitions and interpretation**

# 1. In this privacy policy, the following definitions are used:

**Data** — collectively all information that you submit to **Apirox**, **s.r.o.** via the Website. This definition incorporates, where applicable, the definitions provided in the Data Protection Laws. **Data Protection Laws** — any applicable law relation to the processing of personal Data, including but not limited to the GDPR, and any national implementing laws, regulations and secondary legislation, for as long as the GDPR is effective in the Slovak republic

**GDPR** – the General Data Protection Regulation EU 2016/679

We or us – Apirox, s.r.o., Prostějovská 4823/11 080 01 Prešov, Slovak Republic, Identification Number (IČO): 47 455 705, incorporated in Business Register of the District Court Prešov, section: Sro, Insert No.: 29070/P.

**User or you** — any third party that accesses the Website and is not either employed by **Apirox**, **s.r.o.** and acting in the course of their employment or engaged as a consultant or otherwise providing services to **Apirox**, **s.r.o.** and accessing the Website in connection with the provision of such services

**Website** - the website that you are currently using, <a href="https://www.apirox.com/">https://www.apirox.com/</a> and any subdomains of this site unless expressly excluded by their own terms and conditions

## 2. Scope of this privacy policy:

This privacy policy applies only to the actions of **Apirox**, **s.r.o.** and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites. For purposes of the applicable Data Protection Laws, **Apirox**, **s.r.o.** is the "data controller". This means that **Apirox**, **s.r.o.** determines the purposes for which, and the manner in which, your Data is processed.

## 3. Data collected

We may collect the following Data, which includes personal Data, from you: name, surname, email contact, telephone numbers, financial information such as bank account number, in each case, in accordance with this privacy policy.

# 4. How we collect Data

We collect Data in the following ways: Data is either given to us by you or Data is collected automatically.

# 5. Data that is given to us by you

**Apirox, s.r.o.** will collect your Data in a number of ways, for example: when you contact us through our website, by telephone, post, email, or when you make payments to us, or when you use our services, in each case, in accordance with this privacy policy.

# 6. Data that is collected automatically

To the extent that you access the Website, we will collect your Data automatically, for example: We automatically collect some information about your visit to the Website. This information helps us to make improvements to Website content and navigation, and includes your IP address, the date, times and frequency with which you access the website and the way you use and interact with its content.

### 7. Our use of Data

Any or all of the above Data may be required by us from time to time in order to provide you with the best possible service and experience when using our Website. Specifically, Data may be used by us for the following reasons: internal record keeping, improvement of our products, services, in each case, in accordance with this privacy policy.

We may use your Data for the above purposes if we deem it necessary to do so for our legitimate interests. If you are not satisfied with this, you have the right to object in certain circumstances (see the section headed **Your rights** below)

When you register with us and set up an account to receive our services, the legal basis for this processing is the performance of a contract between you and us and or taking steps, at your request, to enter such a contract.

#### 8. Who we share Data with

We may share your Data with the following groups of people for the following reasons: our employees, agents, and or professional advisors like accountants, or relevant authorities to facilitate the detection of crime or the collection of taxes and duties, in each case, in accordance with this privacy policy.

### 9. Keeping Data secure

We will use technical and organisational measures to safeguard your Data, for example: access to an account is controlled by a password and a user name that is unique, or we store the Data on secure servers, or the technologies are using the SSL

We are using standards stated in the **ISO 27001**. This family of standards help us manage your Data and keep it secure.

# 10. Data retention

Unless a longer retention period is required or permitted by law, we will only hold your Data on our system for the period necessary to fulfil the purposes outlined in this privacy policy or until you request that the data be deleted.

Even if we delete your Data, it may persist on backup or archival media for legal, tax or regulatory purposes.

# 11. Your rights

You have the following rights in relation to your Data:

• **Right to access** – the right to request copies of information we hold about you at any time, or that we modify, update or delete such information. If we provide you with the

access to the information we hold about you, we will not charge you for this, unless your request is manifestly unfounded or excessive. Where we are legally permitted to do so, we may refuse your request. If we refuse your request, we will tell you the reasons why.

- Right to correct the right you have your Data rectified if it is inaccurate or incomplete
- Right to erase the right to request that we delete or remove your Data from our systems
- **Right to restrict our use of your Data** the right to block us from using your Data or limit the way in which we can use it
- **Right to data portability** the right to request that we move, copy or transfer your Data
- **Right to object** the right to object to our use of your Data including where we use it for our legitimate interests

# 13. Links to other websites

This Website may, from time to time, provide links to other websites. We have no control over such websites and are not responsible for the content of these websites. This privacy policy does not extend to your use of such websites. You are advised to read the privacy policy or statement of other websites prior to using them.

### 14. Changes of business ownership and control

**Apirox, s.r.o.** may, from time to time, expand or reduce our business and this may involve the sale or the transfer of control of all part of the business. Data provided by Users will, where i tis relevant to any party of our business so transferred, be transferred along with that part and the new owner or newly controlling party will, under the terms of this privacy policy, be permitted to use the Data for the purposes for which it was originally supplied to us. We may also disclose Data to a prospective purchaser of your business or any part of it. In the above instances, we will take steps with the aim of ensuring your privacy is protected.

### 15. General

You may not transfer any of your rights under this privacy policy to any other person. We may transfer our rights under this privacy policy where we reasonably believe your rights will not be affected.

If any court or competent authority finds that any provision of this privacy policy is invalid, illegal or unenforceable, that provision or part-provision will, to the extent required, be deemed

to be deleted, and the validity and enforceability of the other provisions of this privacy policy will not be affected.

Unless otherwise agreed, no delay, act or omission by a party in exercising any right or remedy will be deemed a waiver of that, or any other, right or remedy.

This Agreement will be governed by and intercepted according to the law of Slovak republic. All disputes arising under the Agreement will be subject to the exclusive jurisdiction of the Slovakian courts.

#### 16. How we use cookies

Our website uses cookies. A cookie is a small text file that which may be stored on your browser or your device.
